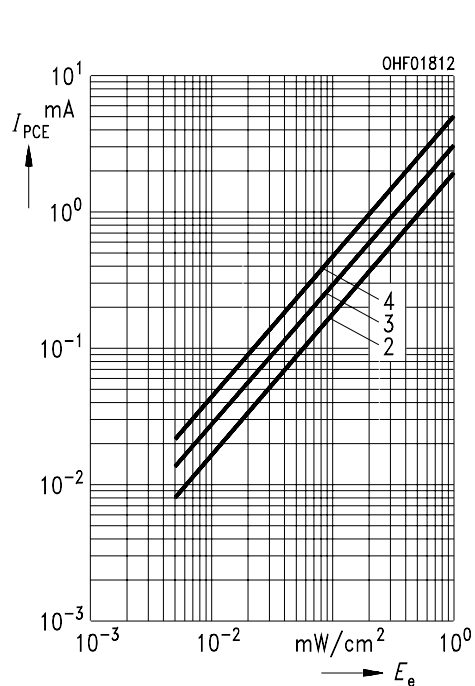

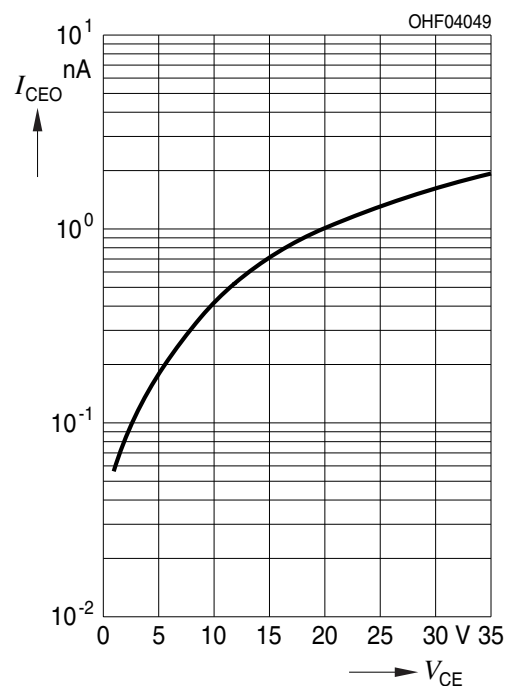

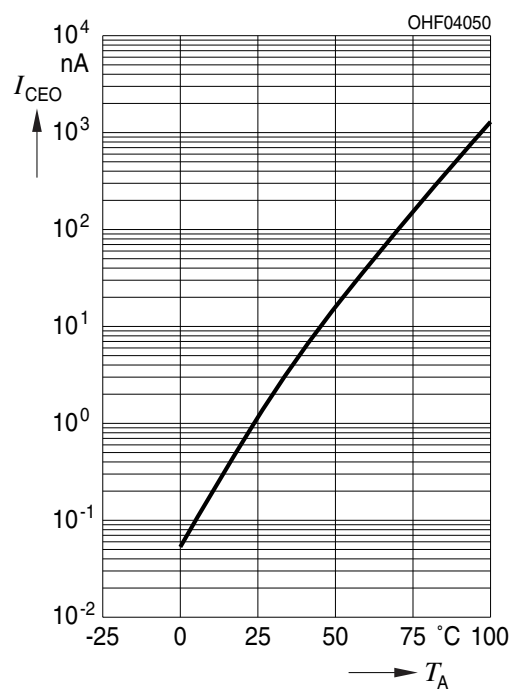

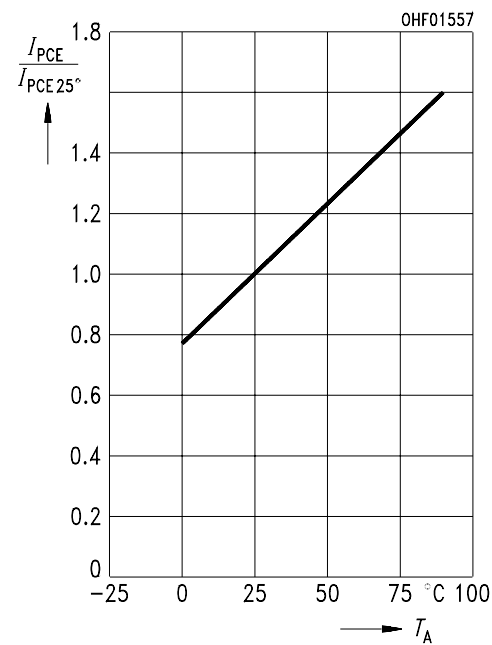
Dark Current ⁴⁾

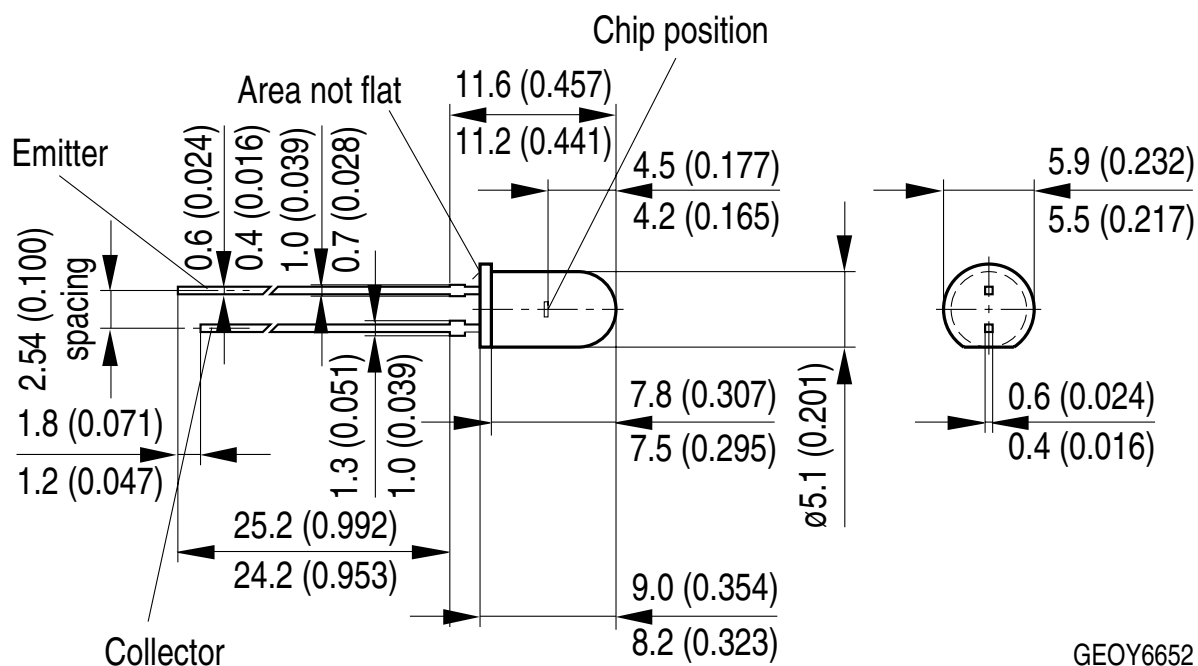


Photocurrent ⁴⁾

Dimensional Drawing ⁶⁾



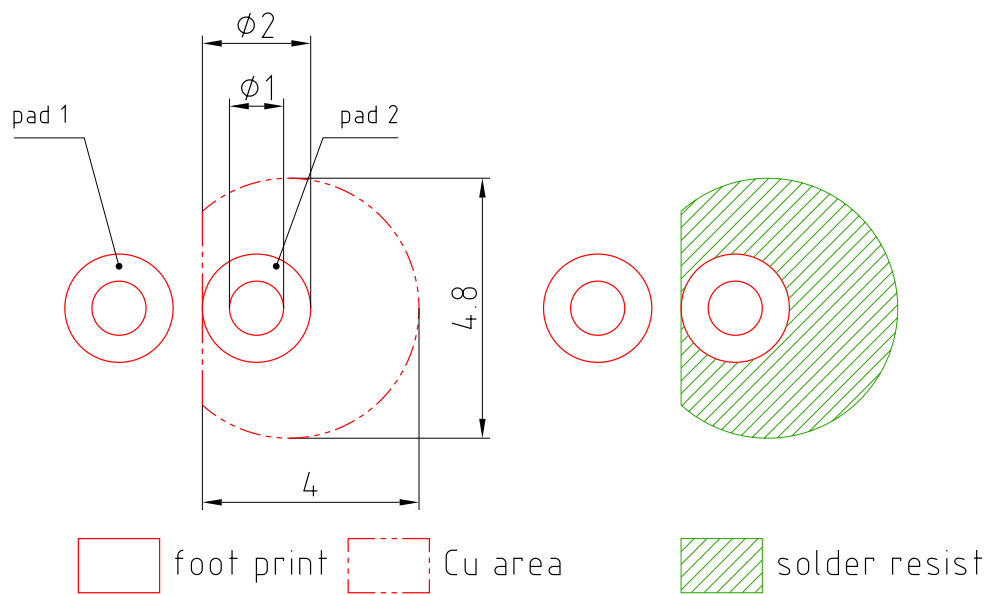

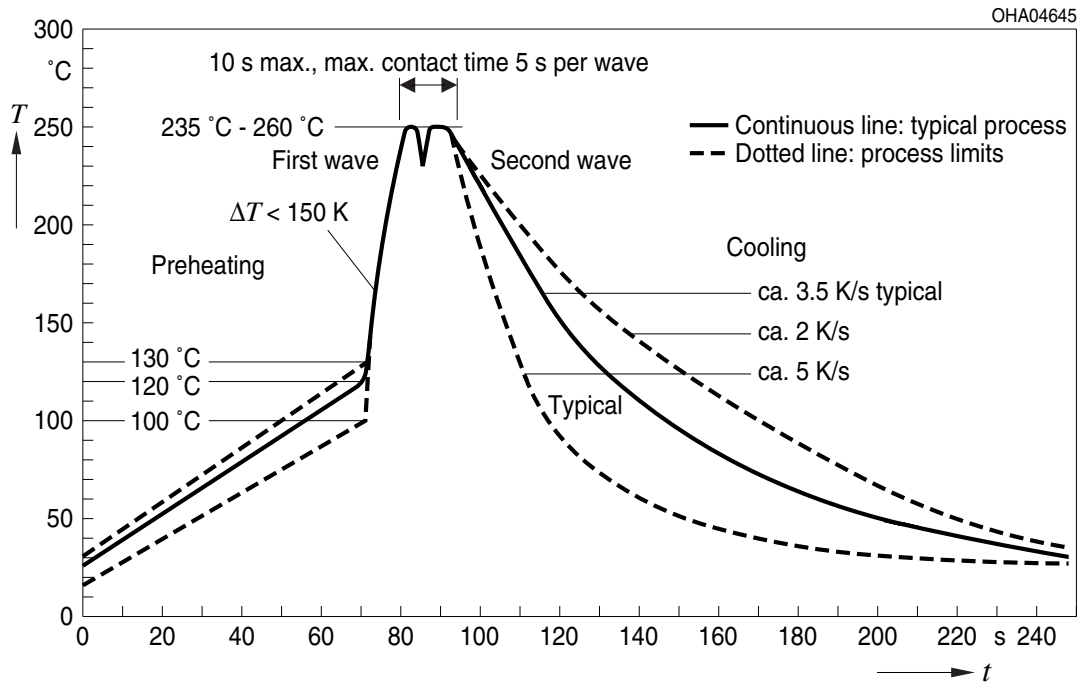
