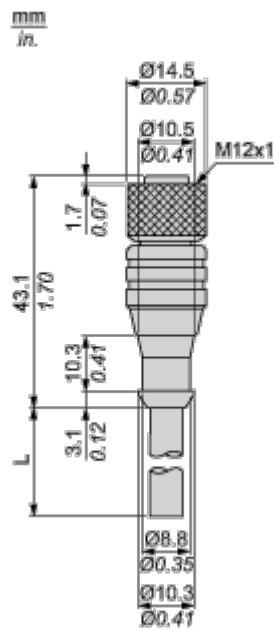

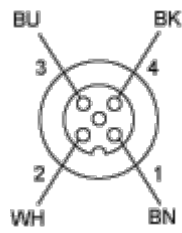


L : Length of cable
