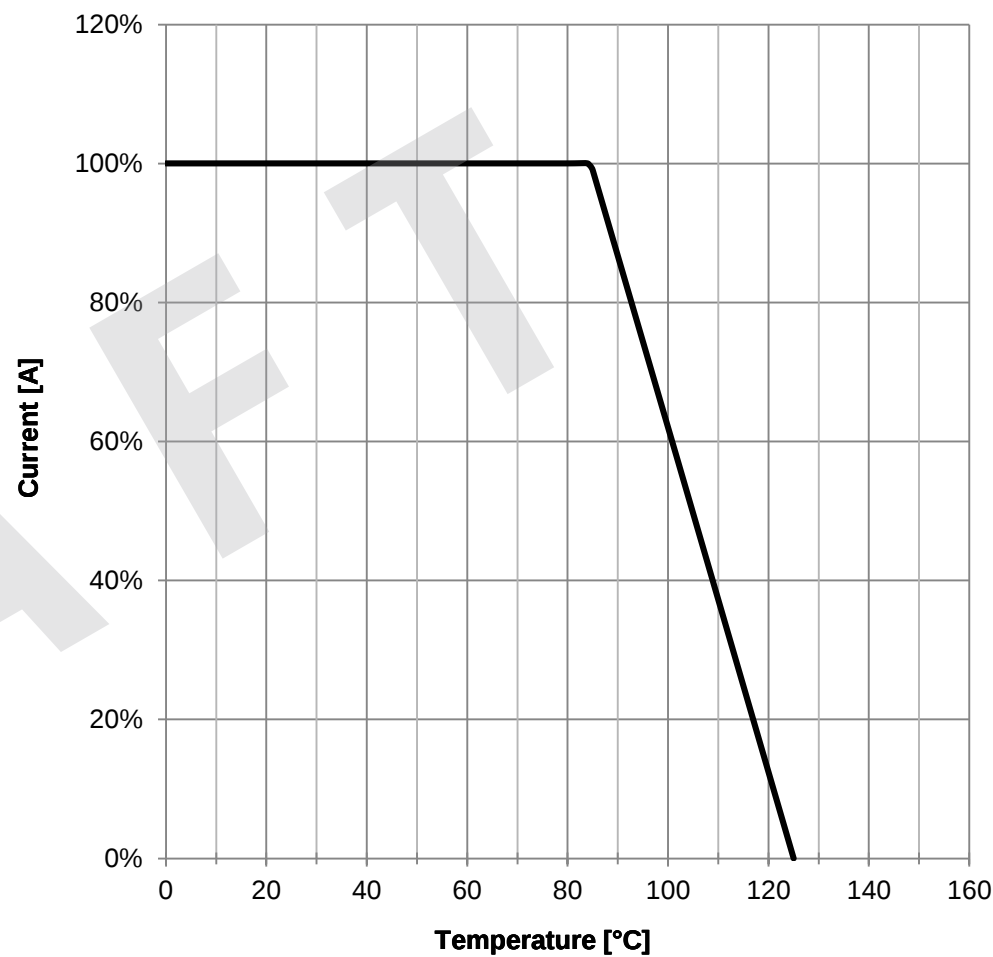

Soldering:

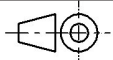

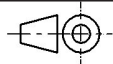
